¹ NOTE: notice required to terminate lease might be different from this notice required to provide partnering families. Reviewing your lease details and the Residential Tenancies Act will help you determine how much notice you are legally required to give your landlord. We encourage you to inform partnering housemate/family of your intention to end the partnership first then discuss arrangements concerning the lease.
